One Time and Scheduled Payments

By activating the Service, you have consented to receive account statements electronically. You will receive an e-mail notification each time a new account statement is available for online viewing. The account statement you see online is a PDF copy of the paper version.

There is no charge by the Creditor for the Service at this time, however, you should check with your bank for any additional charges. Creditor reserves the right upon notification to terminate the Service at any time. All charges, terms and conditions are subject to change.

You have authorized us to treat your electronic signature as evidence of your consent to initiate this electronic payment transaction from your Funding Account. This authorization via electronic signature has the same effect as a handwritten signature on a paper-formatted contract.
